Flexible Parent Meetings:

The staff at Turner Elementary believe that it is important that parents are involved in the education of their children; therefore, we have put measures in place to further increase parental involvement from year to year. We will offer programs and trainings in the evenings so that parents that work during the day may attend. Information will also be presented in the mornings for parents whose schedules do not allow them to meet in the evenings. Teachers will be flexible regarding their parent conference times. VPK teachers will conduct home visits in order to establish a relationship between teachers, student and parent. Title 1 materials are available for checkout during the day and during parent conferences or Title 1 meetings. The parent resource area is located in the conference room and checkout can be done through contacting the Title 1 coordinator. Parents will receive resources at Parent Curriculum Events. Parents provide input on surveys at parent events and annually on a district scheduling of meetings and activities.

Parents voiced a desire to have evening meetings on various week nights — not to set the same week night for the meeting. Translation will be available during school events.

Twice a semester, parents are invited to meet with the principal. This will allow parents the opportunity to discuss questions or concerns they may have. It also allows the principal to share information about new programs, celebrations, and progress within the school.

Building Capacity:

Title 1 coordinates with Joy Lutheran Church, BCASCA (Brevard Caribbean Association), First Presbyterian Church, Harris Hero's, and CenterPointe Church which provide school supplies, clothes, shoes, backpacks and food for students in need. CenterPointe Church facilitates monthly Big Idea assemblies which teach students about Lifeskills through skits and music. Parent Involvement meetings are scheduled monthly to discuss Community Resources, Learning at Home, Parenting in Today's World, Safety, and Volunteering. Title 1 schedules numerous nightly events as an opportunity to provide parents with specific strategies to increase their child's academic performance and to develop a deeper understanding of various content area expectations. Parents are highly encouraged to attend the Title 1 events, which include: Sock Hop October 12th, Barnes and Noble night October 25th, Cookies and Milk with Santa November 29th, Holidays Around the World December 13th, FSA night January 24th, Dr. Seuss night February 28th, Celebration of the Arts on May 8th, Curtain Call May 15th and Volunteer Appreciation Breakfast May 21st. To support students with their academic achievement and Positive Behavior, Title 1 schedules quarterly awards ceremonies. Parents are highly encouraged to attend: November 1st and 2nd, January 30th and 31st, April 10th and 11th, and May 24th and 29th. A parent resource center, located near the front office, has materials & resources available for check out. Parent resources are also available during Title 1 nights. Title 1 materials are available for parents and are accessible through the front office. Computer labs are available for parents to access Edline, Accelerated Reader, Volunteer Application and Brevard County School Edline page, if they are unable to do so from home. Turner Administration offers Principal Chats during Open House. Administrators are also available during Title 1 nights, Volunteer Orientation, Conference nights, and Student Recognition Ceremonies.

Parents were given the opportunity to share their concerns regarding meeting times and nights with surveys. Also, during the Parent Involvement Booster (Turner PRIDE) Meetings, parents brainstormed ideas to engage parents who are not able to attend. By utilizing Facebook Live and other social medias we can involve more families. For the 2018-2019 Parent and Family Engagement Plan, parents and community members were invited to attend monthly meetings beginning in the fall of the 2017-2018 school year. Staff Development:

The Turner faculty will establish and monitor a safe, orderly, and productive learning environment by developing positive relationships with all stakeholders in order to help them reach their social, emotional, and academic potential with consistency and fidelity.

Turner teachers will participate in various book studies. Teachers will be able to choose the title of their choice. The goal of these book studies is to provide researched based strategies, ideas from colleagues and collaboration to continue in strengthening relationships with students. The book titles to choose from are: Better Carrots Then Sticks, Engaging Students with Poverty in Mind, and You've Gotta Connect. The book study and collaborative discussions are planned to develop an understanding of the struggles our students face, the relationships we need to build and the accountability that the students need to be held to. Instructional staff will participate in Guided Reading Professional Development to enhance the reading instruction within the classroom. Turner staff will receive training on Meeting the Needs of All. The purpose of the training is to build a cohesive building where all students can learn.

Other Activities:

• A parent resource center is located in the front office where resources are available to be checked out. Parent resources will also be available during our many Title 1 nights. Title 1 materials are available in the front office for parents. Computers in our lab are available for parents to access Edline, Accelerated Reader, and Brevard County School Edline page, if parents are unable to access them at home. The Administration offers Principal Chats at a booth during Open House, Title 1 nights, Volunteer Orientation, Conference nights, and Student Recognition Ceremonies.

Communication:

Turner Elementary hosts multiple family events throughout the school year. Information regarding Title 1 programs will be distributed at the Annual Title 1 Meeting at the beginning of the school year. During the annual meeting, we will also distribute explanations and descriptions of the curriculum at the school, the forms of academic assessment used to measure the student's progress, and the proficiency levels students are expected to meet (Section 1116(b)). Included in this are Florida's academic content standards, Florida's student academic achievement standards, local academic assessments including alternative assessments, requirements of Title 1 and how to monitor their child's progress. All students enrolling after the annual meeting will receive these materials when registering in the front office. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, indecisions relating to the education of their children (Section 1116(b)) will be provided through regular scheduled meetings during district conference nights. Dates and method of distribution of required documentation is noted on individual teacher class lists for each students. The PowerPoint and Sign-in sheets will serve as documentation that the information was provided during the Annual Meeting. Sign-in sheets will be collected throughout the year to serve as documentation for parent requested meetings that cover the information described. We do have little participation on academic based events. After each event we problem solve how to increase participation. We have implemented options such as; dinner or child care provided, family fun activities, different times and different days. Based on the parent survey comments an area for improvement is in the area of better communication between teacher and parent. We plan to increase communication through providing instructional coverage if teachers need that time to make phone calls, discuss parent communication throughout our trainings, discuss parent communication in data meetings and promote open communication with all. Turner Elementary offers Principal chats for parents, administration booths at Open House and Conference nights, quarterly awards programs, monthly student recognition programs, and volunteer opportunities. At the end of each event, we review parent written feedback to use to plan future events that reflect their opinions. Looking at the parent survey an area of improvement is to focus on ways to include parents in

decision making. We have included decision making during our School Advisory Council meetings and throughout feedback sessions. We will ensure that the PFEP, SIP, CAN, and other notifications are shared with community stakeholders by advertising on our school marquee, advertising in the PawPrint Newsletter, sending home fliers, sharing fliers with local business' and churches.

Accessibility:

All information related to school and parent programs, meetings, and activities, in the extent possible, will be in an understandable format and will be available in other languages if requested by the parent. Alternative formats will also be provided upon the request of parents with disabilities as needed. Multiple staff members speak Spanish and are available to assist with communication between teachers and staff to Spanish speaking parents. Translation devices have been purchased to assist with speakers of other languages.

Discretionary Activities (optional):

Monthly Parent Involvement activities will be held on the last Thursday of each month. Topics will be discussed based on parent/family interests. Topics of interest are: Medicaid, lice treatment/prevention, social media/bullying, social emotional learning, improving behaviors at home, how to be a better parents, reading/math skills, and test taking. Outside specialists will be brought into the school to discuss/teach the parents about the topics.
